The second issue that you will be asked to vote on is a school board policy that includes _____. Voting to uphold the regulation means that the rules will stay the same, while voting to overturn the current regulation means the current rule will be thrown out and replaced.

In-Person Voting Requirements

In person voting must take place at the polling location appointed by your polling coordinator. Only one person may vote at a time in the privacy of the voting booth. No information will be given to you at the polling location on the materials you are voting on. You are expected to be an informed citizen. The polling location will only be open for five minutes. If you fail to cast your vote, you will not have a say in this election.

Teacher Instructions
